Lake level has risen to 556.352 msal as of August 6, 2020 from 555.91 msal, the low point in 2013

Winter oxygen levels up but not high enough to support

larger fish species. Lake is showing slow improvement.

MLBMS Projects and Activities For 2020

Beavers - installed one beaver exclusion fence \$400, removed beaver deceivers from East side of lake.

Solstice - digital elevation model complete. Files transmitted for future use.

- Stream analysis complete elevation of 10 stream and 9 branches
- Study indicated many locations of concern beaver dams, orphan well access road, f/u in progress, physically visit sites and when access is difficult, drone video will be used
- Further work included specific locations and any changes in ground cover
- Winter Oxygen Monitoring, summer X- Stream Science creek monitoring, Lake watch funded by LICA
- Continuing groundwater monitoring, need one new well
- Fundraising annual roadside clean-up, bottle return program, donations, grant for DEM, application for raffle
- Communications website, Facebook, e-mail, membership list
- MLBMS needs a new website manager, Facebook moderator.
